

High school students from all over Western New York will have to opportunity to participate in a stock market challenge simulation for <u>two weeks</u> as part of their <u>JA Take Stock in Your Future®</u> program.

The purpose of the JA Stock Market Challenge is to give students a better understanding of trading strategies and portfolio management.

Students will also learn and practice 21st Century skills such as critical thinking, problem solving, communication and collaboration.

This challenge will take place virtually for two weeks in November 2023 and March 2024, culminating in a half-day in-person championship event in April 2024.

Students will work as a team or individually and make their own trades using fictitious money based on real stock market activity, trends and analysis using Junior Achievement's proprietary software.
